The Environmental Protection Agency (EPA) conducts about 21,000 regional inspections each year and assesses administrative, civil and criminal penalties. In one recent year, the penalties totaled more than \$228 million and over 320 criminal charges were filed against individuals and corporations by EPA, the FBI and the Department of Justice.

In October 1998, EPA imposed the largest civil penalty ever on several corporations totaling \$87 million.

Clean Air Act (2.0 hours)

Emergency Planning and Spills Reporting (1.5 hours)

Congress passed the Emergency Planning and Community Right to Know Act as a result of a chemical accident that killed several thousand persons in India. You will learn how this and other reporting requirements affect your operation and what you need to do to comply with its requirements.
